### WILDLIFE/PROPERTY FORFEITURE ORDER

Unless otherwise specifically ordered by a United State Court, any wildlife or property which has been seized under the authority of the Migratory Bird Treaty Act, 16 USC 703-711; the National Wildlife Refuge Systems Administrative Act, 16 USC 721-731; The Eagle Protection Act, 16 USC 668-668e; The Endangered Species Act, 16 USC 1531-1542; The Migratory Waterfowl Hunting Stamp Act, 16 USC 718-718i; The Airborne Hunting Act, 16 USC 742j-1; The Marine Mammal Protection Act, 16 USC 1361-1407; The Tariff Classification Act, 19 USC1202; The Lacey Act, 18 USC 42, The Lacey Act Amendments, 16 USC 3371-3378; The American Antiquities Act, 16 USC 433; The African Elephant Conservation Act, 16 USC 4201-4245, The Archeological Resources Protection Act, 16 USC 470aa et seq.; and The Wild Bird Conservation Act, 16 USC 4901-4916, where in the final disposition of the case has been made by either payment of a forfeiture of collateral or a judgement by the Court on behalf of the government and where so authorized by statute, such wildlife or property shall be forfeited to the U.S. Government and disposed of by the U.S. Fish and Wildlife Service in the manner prescribed by Title 50, Code of Federal Regulations, Part 12.

### MANDATORY COURT APPEARANCES OR ARRESTS

Recognizing the concern of the U.S. Fish & Wildlife Service, the U.S. Attorney's Office and the various other state and federal wildlife agencies regarding recidivists and aggravated offenses, it

is herein provided that if circumstances warrant, the law enforcement officer will contact the U.S. Attorney's Office and request a mandatory court appearance before the appropriate U.S. Magistrate Judge. Certain violations are herein already described as a mandatory appearance violation because of the serious nature of the offense. Nothing herein shall prohibit the law enforcement officer from arresting a person for the commission of any offense including those for which collateral may be posted and forfeited and taking said person immediately before a United States Magistrate Judge if so warranted.

## FISH, WILDLIFE & PLANT RESTITUTION TABLE

Restitution amounts listed below may be added to the collateral amounts whenever the schedule provides for restitution in addition to the stated collateral amount. Values shall be assessed on a per capita basis (i.e. separate value added for each fish, wildlife and plant species possessed, transported, killed, etc. in violation of the law).

In cases where the restitution amounts noted in the table are lower than the declared value of the item, the higher of the two amounts shall be used.
